Discussion:	Keerthana:	There will not be much change for the financial and the budget year-over year. Our Levy is approximately 75,000. Once the audit is completed, we will be receiving the remainder of our levy funding. There are some small grants or donations received by AHC and/or from HOUSE Canada.
		Key expenses to payroll and for the audit. Some funding went to events and honorariums
		Total payroll was 39,000 last year, which has been subsidized by HOUSE. Going forward into the current fiscal year, as we have a new staff joining in April 2022, this will increase. 40% of their salary will go towards housing. We have cash flow issues, but we are not spending over our means.
		Money owed from York (\$39,000) Expense - Audit
		Background pre, negotiations, meeting, and salaries account for the largest sum of finances.
		Backstops preventing us from receiving funding is the Audit - the auditor is responsible for 8 levy groups at York. We've changed the structure of

the timing when books are done to get it a lot quicker to prevent this kind of blockage.

 - Nathi: Perhaps hosting the AGMs in may to ensure that we can do things during the academic year.

 - Keerthana: Seems like the beginning of August and/or early September might be the best time to host the AGM because of student turnover issues and/or auditing requirements
